



Application for Standard Membership

Thank you for your interest in the Lawrenceville Swimming Association. Enclosed is information about our standard membership, including application, bond, initiation, and membership fees. Applicants and members must be residents of Lawrence Township, NJ.

LSA is a private, cooperative swim club of approximately 175 families established in 1960, and located on Craven Lane in Lawrenceville, New Jersey. We are open Memorial Day through Labor Day each year. We enjoy a competitive-sized pool, with lap lanes, wading area (from 2 ½ to 3 ½ feet deep), and a diving well. LSA also has a separate, fenced-in shallow wading pool for infants, and younger children. The bathhouse facilities include rest rooms, showers, and dressing areas, while the fenced, grassy grounds include playground equipment, picnic tables, and shuffleboard courts. Lounge chairs and umbrellas are provided for members. A professional manager and staff supervise the pool and its activities.

LSA has several ongoing activities for the benefit of its members. The swim and dive teams compete with local swim clubs, while the lifeguards offer swimming lessons to children. In addition, a variety of social events are planned throughout the season, catering to people of many different ages. Since we are a cooperative club, members are expected to contribute several hours of work at the club each season. This participation can be met in many different ways.

Standard Membership provides full use of all club facilities for you and your guests, includes voting privileges, and makes you a part-owner of the club. There is a \$35 non-refundable application fee, and later, upon acceptance, a one-time \$100 initiation fee and the purchase of a bond, currently valued at \$750. This bond represents a member's share of the club's capital investment, and is redeemable (under the conditions of the bylaws) if membership is terminated. In addition, there are annual dues that cover the operating budget (currently \$600 plus \$50 per child). You are encouraged to bring guests (\$4 for adults, \$2 for children) and even host your own parties on-site.

Once your application and fee are received, you will be placed on our waiting list, and notified when your membership comes up for approval. If you move out of the township, or are no longer interested in LSA, please notify us so we can remove your name from the list.

MEMBERSHIP DUES SCHEDULE

- Base Dues \$600 Resident-Family Membership
- Children Fee \$50 per child age 2 to 21 (as of June 1st)
- Additional Family Fee \$75 per person over 21 (living at member's home)

If you are offered membership and accept, you will become responsible for these annual dues and fees, which are subject to change. If you are accepted mid-season (after June 30), you may be billed a pro-rated amount.

INITIATION FEE AND MEMBERSHIP BOND

If you are offered membership and accept, you must pay a one-time **\$100 initiation fee** and buy a **\$750 Membership Bond**. If you drop your membership, your bond will be purchased back by LSA when you are replaced by another member. Bonds are NOT transferable.

SIGNATURE REQUIRED

As a resident of Lawrence Township, NJ, I hereby make application for membership in the Lawrenceville Swimming Association ("LSA"). I understand that my **application fee of \$35** is non-refundable. I further understand that if I am accepted, my initiation fee and bond fee must be received within 14 days of the date of my acceptance, or the offer of membership will be withdrawn, and I will be removed from the wait list. Further, my first season dues will be due on March 15, or 30 days after acceptance, whichever comes later.

In the event I accept an offer of membership into LSA, I hereby agree to abide by all of the rules and regulations of the Lawrenceville Swimming Association ("LSA") as may be adopted from time to time. I agree to pay the balance of my dues and other assessments on or before March 15 of each year. I hereby waive the right to make claims against the Association on account of any and all losses, damages or injuries suffered by my family and me. I further agree to indemnify and hold harmless the Association for any and all claims, damages and liabilities that may be assessed against the Association by my family, my guests and myself.
